This report has been prepared in order to comply with the Head Start Reauthorization Act of 2007. The Act states that:

The Mission of **Region 14 Educational Service Center** is to support the educational community through quality services that assure excellence, equity, and efficiency.

The mission statement of **Region 14 Educational Service Center Head Start** is to support schools and collaborate with schools and communities to promote and support high qualify Head Start Programs.





Region 14 Head Start recognizes that children are not meant to: be quiet learners, stay clean at all times, spend lengthy periods of time standing in lines, or stay seated with their hands in their laps. Children learn and develop language and communication abilities through active play during interactions with peers and their environments. Children develop at their own rates, and Region 14 Head Start programs provide children with learning center environments that promote cognitive and motor development, based on children's interests and ability levels. We recognize that children need multi-sensor opportunities to explore their environments and want children to develop to their potentials.





- Assistance to families in accessing all necessary resources for providing safe, healthy, positive parenting experiences for their children in the homes.
- Establishment of successful home-based and center-based (school district) Early Head Start and Head Start programs, strengthening social-emotional, cognitive, physical, language and communication development in birth to five-year olds.
- Commitment to partnering with school districts in providing quality services to our children and families, completely satisfying Head Start Performance Standards.
- Demonstration of continuous improvement in program quality, efficiency, and excellence throughout the Region 14 service area.





ESC HISTORY

In 1967, the Texas Legislature directed that the State Board of Education provide, by rules and regulations, for the establishment and operation of regional education service centers. Twenty regional service centers provide services to school districts. The centers are service organizations, not regulatory arms of the Texas Education Agency, and participation by schools in services of the centers is voluntary.

Each education service center is governed by a seven member board who are elected by members of local school districts. In addition, education service centers are directly accountable to the Texas Commissioner of Education.

Statutory Purposes Regional Education Service Centers shall:

- 1. assist school districts in improving student performance in each region of the system;
- 2. enable school districts to operate more efficiently and economically; and
- 3. implement initiatives assigned by the legislature or the commissioner.



General Start HISTORY



1999: ESC 14 Head Start funded to serve 128 Head Start children and families in **four counties** (7 center-based sites in 7 school districts and 1 home-based program).

2002-2003: ESC 14 Head Start funded to serve 144 Head Start children and families in **five counties** (8 center-based sites in 8 school districts and 1 home-based program) with the addition of Taylor County outside of Abilene.

2004-2006:

ESC 14 Head Start funded to serve 341 Head Start children and families through acquiring three more counties (i.e. Fisher, Mitchell and Nolan counties) serving 197 Head Start children and families and 40 Early Head Start children and families (Birth to 3). Head Start children and families are now served in 18 Head Start classrooms in 11 school districts and 1 home-based program, and Early Head Start children and families are now served in 5 Early Head Start classrooms in 1 school district.

2009:

ESC14 Early Head Start funded to serve 16 additional children and families (Birth to 3). Early Head Start children and families are now served in 7 Early Head Start classrooms in 1 school district. Head Start children and families are now served in 18 Head Start classrooms in 11 school districts and 1 home-based program. Total Early Head Start children funded= 56 Total Head Start children funded= 301



Location

Region 14 Education Service Center (ESC), located in Abilene, Texas, provides technical assistance and consulting services to Central Texas area school districts to help improve student performance and increase the efficiency and effectiveness of local school operations. Region 14 ESC assists in implementing initiatives assigned by the legislature or the Texas Commissioner of Education.

Region 14 ESC Head Start is in eight counties and serves 11 school districts.

Education Service Centers (ESCs) do not possess tax levying or bonding authority and rely on grants and contracts for funding. Revenues are received from three primary sources. State funds provide 20%; federal funds provide 66%; and local funds 14%.

Region 14 Education Service Center Head Start does not possess tax levying or bonding authority and relies on federal grant funding.


Region 14 Education Service Center's fiscal year is from September 1 thru August 31. The required annual financial audit was performed and completed by Davis Kinard & Co, PC on

December 5, 2011 and presented to the Region 14 ESC Board for approval on December 15, 2011.


Head Start/Early Head Start Is...


\$2,268,812 was received for the 2010-2011 Head Start Program and the following diagram represents how those dollars were spent.

Non-Federal Share ~ Head Start In-Kind

For every 80 cents of Head Start/Early Head Start funds received 20 cents must be matched. The federal government also limits administrative cost to be no more than 15% of the total funds received. The following chart demonstrates the amount of

Governance – *This grantee is a public entity*

Each education service center is governed by a seven-member lay board. Members of the Boards of Directors are elected by members of local district board of trustees located in each region.

These boards develop policies regarding center management and operation, programs and services to be offered, and financial support. Also, boards are empowered to employ and dismiss an executive director subject to the approval of the commissioner. The commissioner has broad responsibility and authority concerning the number and location of centers, regional boundaries, and the allocation of state and federal funds among centers.

Accountability

In addition to evaluations performed by Regional Boards and Center clients, each ESC is evaluated annually by the commissioner. This evaluation includes:

1. an audit of the Center's finances.

2. a review of the Center's performance on standards and indicators established by the Texas Legislature and the Commissioner,

3. a review of client satisfaction regarding services provided, and

4. other factors deemed appropriate by the Commissioner.

ESCs found to be deficient based on these accountability measures are subject to sanctions by the Commissioner.

Head Start Policy Council


All parent/guardian members on the Head Start Policy Council must be duly elected by the local Head Start Parent Groups from the Center-based or Home-based options, and must have a child currently enrolled in the ESC 14 Head Start program. Each Parent Group shall elect one delegate and one alternate to the Policy Council. Parent membership will be for one year (maximum 3 yrs.) or until the following year Policy Council.



All Head Start programs undergo an on-site review every three years to see how well the program is complying with the Federal Head Start Performance Standards and other regulations.

Region 14 Education Service Center Head Start last on-site review was December 6-11, 2009 by the Administration for Children and Families.

Based on the information gathered it was established that Head Start and Early Head Start Programs were in compliance.



Creative Curriculum for Preschool

Creative Curriculum for Preschool is used in the Head Start classrooms of Region 14 ESC. This program allows for an ongoing assessment and the ability to analyze the results with the cc.net component. Children are assessed on a total of fifty objectives in the four main goal areas of social/emotional, physical, cognitive, and language development.

Teachers can generate reports on individual children as well as class profiles. Creative Curriculum has been aligned with the Texas preschool guidelines and meshes well with the state adopted curriculum chosen by an ISD.



Enrollment

Enrollment is reported on a monthly basis to the Office of Head Start. The program maintains **100%** enrollment throughout the year.

Region 14 ESC Head Start is funded to serve 356 children, Head Start partnerships with the Independent School Districts – any additional children are funded through the school district.

The Teaching Strategies GOLD Assessment enables users to compare information about the knowledge, skills, and behaviors of an individual child, individual classes, or groups of children with *widely held expectations* that measures the knowledge, skills, and behaviors that are most predictive of school success. The *widely held expectations* group children into three categories:

<u>Below:</u> The numerical rating assigned to the child for a given objective or dimension is lower than those of children within a *widely held expectation*. <u>Meets:</u> The numerical rating assigned to the child for a given objective or dimension meets those of children within a widely held expectation.

<u>Exceeds:</u> The numerical rating assigned to the child for a given objective or dimension

is higher than those within a widely held expectation.

In addition to progressing on all dimensions, the Spanish-speaking demographic group also demonstrated growth on the dimensions that prove English acquisition.

Analysis of Early Head Start

• It is difficult to analyze the Early Head Start Group to *widely held expectations*, because the groups are very small. However the largest group, the 2 to 3-year-olds, had the greatest number of children that were placed below the *widely held expectations* over a variety of dimensions.

Class Observations

Three classroom observations are completed on each Pre-K classroom. The first observation enables the assessment of the classroom environment and best practices. The second observation tool, the CLASS instrument, enables the assessment of teacher-child interactions. The third observation evaluates how much classroom effort is being used to support *Conscious Discipline*.

Three observations that focus on best practices and teacher child interactions are completed in each Early Head Start Classroom

Classroom Staff Surveys

Teacher and aide surveys are distributed each year to establish what needs to be changed and improved, what were the strengths of the program, and to give staff the opportunity to request training. The number one concern is how to reduce paperwork in Head Start and Early Head Start.

Follow-up Plans:

- Train Early Head Start and Head Start teachers on how to understand the meaning of each dimension in the GOLD assessment. Particular emphasis will be placed on those dimensions where children scored lower. A greater understanding of the dimension will give more rater reliability.
- TA will be given to Early Head Start staff as needed to address individual children's needs.
- An emphasis will be placed on mathematics using the Nita Copely's *Introduction to Pre- K Mathematics* math training.
- Class observations and TA will ensure that children that are three-year-old Pre-K age will have the opportunity to use materials, and experience best practices that are appropriate for their age group.
- Teachers will be given summer work to review *Conscious Discipline* and using the *Conscious Discipline Competency Checklist*, write what went well and establish goals to improve classroom management for the next school year.
- Individual class snapshots will be provided for each teacher to help with the understanding of their classroom's progress.
- A work group of teachers will be given the opportunity to work this summer on how to reduce paperwork.

- A work group of teachers will be given the opportunity to write what dimensions look like for Region 14 ESC Head Start in areas that were not written by *Teaching Strategies GOLD*.
- A new portfolio system will be prepared that will streamline paperwork and make the anecdotal information more useful for assessment purposes.
- Teachers will be encouraged to use Language Facilitators to assist with language development in classrooms.
- Young children's first diagnosis for an IEP is usually speech impaired. Some of the individual ratings reveal that further screening may be necessary to establish IEP's that go beyond speech services.
- The information will be given to the ESC Board and Policy Council, other Region 14 ESC Head Start consultants, and the classroom staff.
- Conscious Discipline workshops will be provided for the classroom staff.
- One Head Start staff will attend the Becky Bailey, *Love and Guidance*, training during the summer to promote *Conscious Discipline* in Early Head Start.
- To enhance *Conscious Discipline*, a pilot program will be initiated to assist teachers, parents, and children to give more strategies for children with difficult behaviors. The program is a pyramid model that includes: effective workforce, nurturing and responsive relationships, targeted social emotional supports, and intensive intervention.
